Privacy Policy (last update April 2022)

The protection of your data is very important to me. I therefore process your data exclusively on the basis of the statutory provisions (GDPR, TKG). In this data protection information, I inform you about the most important aspects of data processing on my website.

When you visit my website, your IP address and the beginning and end of the session are being recorded for the duration of this session. This is due to technical reasons and therefore represents a legitimate interest within the meaning of Art. 6 Paragraph 1 lit f GDPR. Unless otherwise regulated below, I will not process this data further.

Processing Purposes of the Data and Legal Basis

In order to provide you with the possibility to use my webshop as comfortably as possible as well as the possibility of contacting me, the processing of your data (email address, telephone number, order request and shipping address as well as bank details) is necessary. The same applies to the designing concepts, in which case spatial data must also be processed. This data processing is necessary to fulfill the contract. Without this data, I cannot fulfil the contract with you. If you contact me via email, the data you provide will be stored for six months in order to process the request and in case of follow-up questions. This is a legitimate interest within the meaning of the GDPR. I will not pass on this data without your consent.

I would like to point out that for the purpose of a functioning shopping process and for contract processing later on, the webshop operator stores the IP data of the connection owner as part of cookies, as well as the name, address and credit card number / bank details of the buyer.

After cancelling a shopping process, the data stored with me will be deleted. In the event of a contract being concluded, all data from the contractual relationship will be stored until the tax retention period (7 years) has expired. The data name, address, purchased goods and date of purchase are also stored until the product liability expires (10 years). The data processing takes place on the basis of the legal provisions of § 96 Abs 3 TKG (Telecommunications Act, Austria) as well as Art 6 Abs. 1 lit b of the GDPR (necessary for the fulfilment of the contract). With regard to your data processed by me, you are generally entitled to information, correction, deletion, restriction, data portability, revocation and objection. If you believe that the processing of your data violates data protection law or that your data protection claims have been violated in any other way, you can complain to me or the data protection authority.
